# INTERNET AND IMAGERY ACCEPTABLE USAGE POLICY

It is important that this document is read carefully, and the last page is signed by parent/guardian and returned to the school.

#### Internet Usage:

As part of the school's education programme, in particular with regard to our interactive whiteboards, we offer pupils supervised access to the internet. This allows pupil's access to a large array of online educational resources that we believe can greatly enhance pupils learning experience.

However, access to and the use of the internet requires responsivity on the part of the user and the school. These responsibilities are outlined in the school's **Internet and Imagery Acceptable Usage Policy**.

Although the school takes active steps to promote safe use of the internet, it recognises the possibility that students may accidentally or deliberately access inappropriate or objectionable material.

The school respects each family's right to decide whether or not to allow their child/children access to the internet as defined by the school's **Internet and Imagery Acceptable Usage Policy**.

Having read the terms of our school's Policy, you may like to take a moment to consider how the internet is used in your own home, and see if there is any way you could make it safer for your family.

#### Website Usage:

I am ever conscious of child protection in relation to digital imagery and wish to address this issue in relation to the school website.

- All publication of student work will be coordinated by a teacher.
- Pupil's work will appear in an educational context on the school website pages.
- The school will endeavour to use digital photographs, audio and video clips focusing on group activities. Content focusing on individual students will not be published on the school website without this parent permission.
- Personal pupil information including home address and contact details will be omitted from the school web pages.
- The school website will not publish the Christian or surnames of individuals with photograph.
- Attached please find a permission from regarding the usage of both the internet & digital imagery. All parents/guardians are asked to please read carefully and return to the school.

#### Review:

In December 2013 this policy will be reviewed by the Board of the Management and every two years thereafter.

A copy of the **Internet and Imagery Acceptable Usage Policy** will be provided on enrolment. The pupils and his/her parents/guardians/carers must read it carefully and sign in the space provided to indicate their acceptance of the **Internet and Imagery Acceptable Usage Policy**.
